Exclusion of Scope of supply and terms for future order for Power Plant MCC, PCC, APFC & BUS DUCTS:

Please note that Air circuit breakers, Switch fuse units with fuses, Power Contactors, Control Contactors, Surge Suppressors, Thermal Overload Relay & Electronic Motor Protection Relays shall be supplied to you by us. However all these equipments shall be installed by you in MCC, PCC & APEC Panels. All other remaining equipments to complete the scope of supply shall be supplied by you.

The above mentioned scope of supply shall not be treated as final, as our detailed engineering is going on, any addition or deletion may take place in the mentioned scope of supply. The rates for addition & deletion of feeder modules, one complete vertical bay including Bus Bar Extension, wiring, links and all other accessories are as per Annexure IV.

We may order MCC, PCC, APEC & BUS DUCTS required for our Power Plant for this project on same rates in case of tech specs are same or for different specs and size of Panel the rates on prorate basis shall be calculated by mutual consent.

2.0 PRICE:

the total price for above scope of supply will be **Rs. 200.00 lacs (Rs. Two hundred lacs only)** Ex Works, exclusive of excise duty and VAT.

MIL-CEM will not be liable to pay any duty / taxes on purchase of raw-materials or components which may be required for manufacturing at Suppliers / Sub Suppliers works, including variation therein during currency of the contract.

3.0 TERMS OF PAYMENT:

- 3.1 Payment of contract price shall be made as given hereunder:
 - i) 10% of the Purchase Order value on signing the contract on submission of Post dated Cheque of 10% order value.
 - ii) Further 5% of the Purchase order value after approval of drawings, which you shall submit within 15 days of this Purchase Order.
 - iii) 75% Payment along with taxes and duties shall be paid against proforma Invoice on prorate basis prior to dispatch.

5.0 DELIVERY:

- 5.1 It is understood by and between the parties hereto that the delivery is the ESSENCE of this contract as stipulated in the contract subject to force majeure conditions.
- 5.2 In the event any delay in the delivery of the scope of supply owing to force majeure conditions which directly affects the delivery of parts ready for despatch, revised delivery schedule shall be prepared as mutually agreed upon.
- 5.3 A detailed delivery schedule will be prepared well in advance by the Supplier and submitted to "MIL CEM". The delivery schedule shall be approved by MIL CEM. However, total delivery period shall not exceed period stipulated herein below.
- 5.4 You will deliver all the Panels covered under scope of supply by 31st.

 December -07. However, in case of delay, liquidated damages would be applicable it 0.5% per week on unexecuted order value, subject to maximum of 5% after 7 months from the date of the LOI.

6.0 INSPECTIONS AND TESTS & DESIGN CONFERENCE:

- 6.1 M/s MII, reserves the right to inspect Panels at suppliers works. Supplier shall intimate the date of readiness of Panels at least 15 (fifteen) days in advance through E-mail / Fax before it is ready for inspection. The "MIL-CEM" shall intimate the Supplier within 7 (seven) days of the above notice their willingness to inspect the goods ready in the period specified. In absence of this confirmation, the Supplier has the right to dispatch the Panels on the basis of his internal inspection. In such case, copy of final internal inspection certificate shall be made available, for his verification at a later date.
- 6.2 The Supplier shall apply the inspection and testing techniques normally practiced by it or specifically called for in the specifications to the equipment, and records of all inspections made by the Supplier shall be kept complete and available to the MIL-CEM.
- 6.3 The design of the Panels is based on the recognized industrial standard specifications employed in India.
- In case an item of Suppliers supply is found to be defective in material or workmanship or otherwise not in conformity with the specifications, the MII-CEM shall have the right either to reject such item or to require its replacement or rectification at the cost of the Supplier.



- 4.5 The inspection and test by the MIL CFM of an item of Suppliers supply shall not relieve the Supplier from the responsibilities regarding warranties and the guarantees provided for in this contract.
- 6.6 Heat Run test (Temperature rise) shall be conducted on one PCC & Two MCC of clients choice free of cost all your works in presence of clients representative.

7.0 PROGRESSIVE REPORTS AND BAR CHARTS:

After the receipt of our purchase order, you shall show your activities of purchase of brought out items, manufacturing and testing in the form of bar charts which shall be submitted to us within four weeks from the date of order. We shall review your activities every month to ensure that the activities shown in the bar charts are functioning properly. You shall also send us a progress report every month by 5th of next month.

8.0 LIQUIDATED DAMAGES:

limely delivery of material is the ESSENCE of this order. In case the delivery is not made within the delivery period mentioned above, we shall charge liquidated damages not as a penalty @0.5% (point five percent) of the total order value per week's delay subject to a maximum of 5% (five percent) through inevocable bank guarantee against late delivery.

9.0 WARRANTIES & GUARANTEES

<u>WARRANTIES</u>:- The SUPPLIER warrant that all articles supplied by them shall be free from any defect(s) in material and/or workmanship and further warrants the quality to be free from any defect(s), mechanical and to confirm to the specifications and requirements of this contract for 12 months from the date of successful commissioning of the Panels.

MIL-CEM shall notify Supplier in writing or by e-mail/fax, immediately upon discovery of any defect(s) for which claim is to be made under this warranty. Immediately upon receipt of such notice the Supplier shall submit by fax or e-mail their comments and recommendations about the actions to be taken.

Supplier shall remedy, after and/or replace within a quickest possible time, any defect(s) against which the Panels is warranted under the warranty.

All costs for the repair, replacement, alternation and/or transportation shall be for the account of the Supplier.

<u>GUARANTEES</u>:- The Supplier guarantees that the equipment shall perform to the specified performance parameters as specified. In case the performance falls short of the guaranteed parameter, the MIL-CEM shall
